Note: At times it is difficult to distinguish whether material be placed in the Reports or Policy category. As a guideline, material found under Policy has to do with a DIRECT discussion of policy. So, for example, there may be something called a "report" but because it contains a discussion of resolutions, it has been filed under Policy.

2. Within each category, material is ordered by date, with the most recent coming first. When there is a month and/or day, it is ordered first. Entries with only a year follow after these entries.

For example: "Blah, blah, Blah," February 10, 1992. "Blah, blah, Blah," January 16, 1992.

3. Material with no date is ordered last.

4. Authors, if any, have been placed after the title (because most sources do not have any author.).

5. Sometimes several pieces of material are in one kit (ie. a convention kit). Important material is listed individually but is filed in the original kit.
