This agreement sets out the conditions under which you can use the data tables available on the CPD, available in Beyond 20/20 in the statistics section of the database.

As a user of these data products, you have been granted a non-exclusive, non-assignable and non-transferable licence to use the data products subject to the terms below. This licence is not a sale of any or all of the rights of the owner(s).

TERMS OF USE

1. The licensee shall not lend, rent, lease, sub-license, transfer or sell any part of the data tables nor any right granted under this agreement to any person or to any other organization.
2. The licensee shall not disassemble, decompile or in any way attempt to reverse engineer any software provided as part of the data tables.
3. The licensee shall not use any part of the data tables to develop or derive any other data product or data service for distribution or commercial sale.
4. The licensee is granted reasonable rights of use of the content of the data tables only for personal or public policy research, as well as for educational purposes. This permission includes the use of the content in analyses and the reporting of results and conclusions, including the citation of limited amounts of supporting data extracted from the data tables in such documents. In such cases, the source of the data must be acknowledged in all such documents and communications by using the citation guide provided on the CPD in the section entitled, "Apply for Statistics Access".
5. The licensee shall obtain approval from the Comparative Perspectives Database before publishing any significant volumes of material extracted from the data tables in any medium.
6. Any violation of this licence renders it void and of no effect. This agreement will terminate automatically without notice if the licensee fails to comply with any term of this agreement. In the event of termination, the licensee must immediately return the data products to the Comparative Perspectives Database or destroy it and certify this destruction in writing to the Comparative Perspectives Database.
